AESF is a qualifying Arizona Student Tuition Organization (STO) for the purpose of the Arizona State Private School Tuition Credits. Tax I.D. Number 86-0973130. A contribution to the Arizona Episcopal Schools Foundation entitles you to a dollar-for-dollar credit against your Arizona state income tax obligation.
