Tax Credits At A Glance

2016 Private School Tax Credit Maximums

Single, Married Filing Separately or Head of Household

Original Individual Credit	\$545
Take MORE Credit	\$542
Total Maximum Tax Credit	*1,087

Married or Filing Jointly

Original Individual Credit	\$1,090
Take MORE Credit	\$1,083
Total Maximum Tax Credit	*\$2,173

***Or the Actual Tax, whichever is less.**

A taxpayer may also be able to claim a federal deduction for the donation.
The taxpayer should consult a tax advisor for specific tax advice.

A school tuition organization cannot award, restrict or reserve scholarships solely on the basis of donor recommendations. A taxpayer may not claim a tax credit if the taxpayer agrees to swap donations with another taxpayer to benefit either taxpayer's own dependent. AESF is a qualifying Arizona STO for the purpose of the Arizona State Private School Tuition Tax Credits.
